## MANGANESE IN SEPTEMBER 2003

In September, reported consumption of manganese ore containing 35% or more manganese, exclusive of that consumed at iron and steel plants, was estimated as 27,000 metric tons (t), which was a 9% decrease from that for the previous month, according to the U.S. Geological Survey. This figure increases to 29,400 t when estimates for annual respondents are added on the basis of 2002 data. Corresponding industry stocks of ore at the end of the month were 291,000 t, which includes an estimate for annual respondents on the basis of 2002 data. This was a 4% increase from that of the previous month.

Foreign trade data for September will appear in a subsequent report. The data for August 2003 tabulated in this report indicate that the total exports, on a manganese content basis, were about 5 times those of July 2003, owing to a significant increase in manganese ore exports. Total imports, on a manganese content basis, increased by about 7% from those of July based on a significant increase in manganese ore and manganese dioxide imports.

**Update**

On October 1, the Defense National Stockpile Center (DNSC) announced the following manganese materials would be available under the FY 2004 Annual Materials Plan: 1) 27,216 t natural battery-grade manganese ore; 2) 2,732 t synthetic

battery-grade manganese dioxide; 3) 36,287 t chemical-grade manganese ore; 4) 45,359 t ferromanganese; 5) 1,814 t electrolytic metal; and 6) 226,796 t metallurgical-grade manganese ore. The FY 2004 Annual Materials Plan is effective through September 30, 2004.

On October 27, the International Trade Administration (ITA) of the U.S. Department of Commerce announced the preliminary results of its antidumping duty administrative review on imports of silicomanganese from Brazil covering the period of December 1, 2001, through November 30, 2002. As a result of the review, the ITA proposed to lower the antidumping duty margin from 88.87% to 2.12% for the subject imports from Companhia Vale de Rio Doce's (CVRD's) subsidiaries SIBRA Electro-Siderurgica Brasileria (SIBRA), Urucum Mineracao, and Companhia Paulista de Ferroligas. The ITA expects to publish final results of the current review within 120 days (International Trade Administration, 2003).
