SODA ASH IN JANUARY 2012

U.S. natural soda ash production in January was 929,000 metric tons (t), 5% lower than the previous month's production of 975,000 t. Total soda ash production in 2011 was 10.7 million metric tons (Mt).

Ending inventories for January 2012 were 341,000 t, 21% higher than the preceding month's inventories. Wyoming trona production in January 2012 was 1.52 Mt.

Exports and imports of soda ash in December 2011 were 517,000 t and 1,560 t, respectively.

The changes in soda ash statistics for December 2011, compared with those of December 2010, were as follows: production was 5% higher; imports were 190% higher; exports were 5% higher; and apparent consumption was 4% higher.

The soda ash end use data for 2011 are shown in table 5.

All percentages in this report were computed using unrounded data.
